Volunteer readers: For every full shift you read, you receive a gift card and six month membership in PRS. If you read two or more shifts, you receive additional gift cards and a one year membership in PRS. If you volunteer to read, a booth assistant (if available) will be provided. You may provide your own assistant. Only one person per fair. We will need their name so we can put it on their badge which will need to be worn at all times at the fair. The reader must agree to supervise and be responsible for this person. Initial _____ As a reader, you must read and sign the PRS Code of Ethics (second page on this download). All readers must submit a Readers Signup Sheet and Code of Ethics. All readers must be 21 years of age or older. Paid readers: Paid readers are by invitation only. If you would like to be considered for a paid reader position, please fill out the reader signup sheet and Code of Ethics. For the program directory we need you to stay within a 100 word count. (You can attach a separate sheet if you like). All readers must be 21 years of age or older. You can have ONE reader's assistant but you must agree to supervise and be responsible for them. We will need their name so we can put it on their badge which will be worn at all times at the fair. PRS Code of Ethics

1. While recognizing that some tools may be needed in different types of readings, interpretation of charts and readings should flow from the heart and mind of the psychic.
2. Psychic talents should be used for quality, not quantity.
3. A psychic has the right to set limits on the time a client can expect for a reading. Be businesslike and on time for reading appointments.
4. When unable to tune-in on a client, a psychic should not attempt a reading. The psychic should so inform the client and return the reading ticket or money.
5. All personal information of clients should be held in STRICTEST CONFIDENCE. NO READINGS WILL BE GIVEN IN THE PRESENCE OF ANY THIRD PARTY WITHOUT THE CONSENT OF THE CLIENT.
6. Constructive advice and clear options that give clients choices and strength should be your goal. Be realistic, not egotistic. Don't play God, guru or games. The clients must make their own decisions.
7. Be objective and reliable in handling client's problems. Be understanding and honest.
8. Assume a confident and positive attitude toward clients problems. Give service and be creative in handling the problems of human nature. Don't be a peddler of doom and gloom.
9. Do not claim to be infallible or insist on the validity of your reading. However, recognize you are responsible for all readings you give.
10. UNSOLICITED READINGS will not be given. Always secure the permission of the person to receive the reading first. Grandstanding tactics, such as spontaneous readings promoting the ability of the reader, will not be engaged in.
11. The reputable psychic does not engage in ominous readings as come-ons given for the purpose of bringing a client back for a future reading.
12. Tipping is not allowed.
